# BROWN COUNTY COMMUNITY UNIT SCHOOL DISTRICT NO. 1 Mt. Sterling, Illinois April 8, 2024

The special meeting of the Board of Education was held on Monday evening, April 8, 2024, at 5:30 p.m. in the Brown County Middle School library. The meeting was called to order by Vice President, Beth Boylen, who served as president pro tem in the absence of President, Dawn Hughes. The minutes were recorded by McKenzie Taute.

**CEO:** The CEO students spoke to the board about the opportunities the CEO program has offered them. Students discussed just a few of the benefits being confidence in public speaking, business planning, finance management, and life skills.

#### Discussion Items:

**Revenue and Expenditure Update**: Eberle explained that as of 04/04/2024 the district was 76% through the fiscal year, had received 470% of expected revenue and disbursed 76% of expected expenditures. Eberle explained that the revenue was skewed due to the bond issues, but expenses were right on target.

**Roof Update**: Eberle reported that the roof and gutter installation project has been completed. He went on to say that Peter's has been working to repair leaks in the middle school. Eberle explained that Peter's will be testing the integrity of the roof with future precipitation and agreed to extend the warranty from two to five years. Eberle also mentioned that the district is working on securing quotes for ice guards and roof repair on the east side of the high school.

**Building Project Update**: Eberle explained that the weight room demolition and tree removal is underway. Eberle also reported that finishes and color selection have begun. Eberle said as supplies arrive, they will be stored in trailers located on site. Eberle also discussed weekly jobsite meetings with Ameresco.

**Hornet Night:** Mr. Ebbing discussed Hornet Night details including the recipient selection process for the first year and future years, auction items, and the plan for proceeds. Ebbing mentioned auctioning off football endzone spots and reserved seats in the gym. Ebbing said Hornet Night will be Saturday, May 18, 2024, at 5:00 p.m. at the American Legion building in Mt. Sterling.

**Next Board Meeting, May 20, 2024, at 5:30 p.m.**: Eberle explained that the senior awards banquet is scheduled for May 20, 2024, at 5:30 p.m. The board agreed to push the meeting back to 7:00 p.m. on May 20, 2024, to eliminate any conflict. Eberle also discussed moving the location of the June meeting to the elementary school to show the board phase one of the intercom project. Gallaher said phase one of the intercom project is almost complete.
